# 1. Goals, Strategy, Vision and Mission

### **Our Goals**

To support a free and sovereign Ukraine in its fight for freedom against its former colonial master Russia by:

- Providing non-lethal support to individual units of the Armed Forces and National Guard of Ukraine,
  Tactical Medical Organisations and others involved in the war against Russia;
- Inform the European public as widely as possible about the war in Ukraine and its consequences and advocate for support to Ukraine;
- To promote documentation of the war and its consequences for the Ukrainian people.

## **Our Strategy**

- To raise money from sponsors, procure non-lethal materials and services (weapons are expressly excluded) and deliver those directly to selected military units and other beneficiaries in Ukraine;
- To organise or support informational events, media campaigns, publications and other public awareness campaigns;
- To provide support to organisations and individuals who document the war and its consequences.

#### **Our Vision**

We will resist by any peaceful means the unprovoked russian war against Ukraine which is a criminal violation of the rights to peace and freedom of Ukrainians and an attack on the global order which mandates non-violent resolution of conflicts between states and on values of democracy, international rules, freedom and human dignity affecting all people of the world. This battle is the frontline of the fight for freedom and democracy against autocracy in Europe and the wider world.

#### **Our Mission**

Our mission is to support the Ukrainian people and its Military until the war against Russia ends, the damages are recovered and the perpetrators of war crimes and crimes against humanity are prosecuted.

# 2. Period of validity

This Policy Plan is a revised version of our Policy Plan of 2022 and will be valid until 31 December 2028 unless the goals of the Foundation have been achieved earlier or the Board decides to prolong its validity or replace it by a new policy plan.

After the end of the war, the Foundation will redirect its activities towards recovery of the damages caused by the war, including mine clearing and support of veterans.

In case the Foundation will be liquidated, any remaining funds will be donated to another fund with comparable objectives and an ANBI status.

# 3. Working method

- a) The Fund has a Board with a President, a Secretary, a Treasurer and other members;
- b) The Members of the Board will present proposals for projects to be funded to the Board based on requests from Military units and others;
- c) The Board decides with a simple majority which projects will be funded as well as on all other matters concerning the Fund, in conformity with its statute;
- d) After approval of the Board, the Foundation will procure the materials related to a project and arrange its delivery to the requesting party in Ukraine;
- e) The decisions of the Board are recorded in the minutes of its meetings or in the records of correspondence by e-mail, WhatsApp, Signal and other media.

# 4. Finances

- a) The fund will appeal through direct contacts, mailings, media, public performances and other methods to potential and existing sponsors to donate money for its work;
- b) Donated funds will be used for projects in Ukraine as fast as responsibly possible;
- c) Reserves can be kept for bigger, long-running projects for up to a year;
- d) Board members will receive no remuneration and will pay for their own expenses;
- e) All income and expenses are recorded in the Fund's internal accounts and by its external accountant;
